- Training Center Report: Rob Giese, CTI Training Director, reported that the Central Training Center in Mosinee will be having an open house for their first anniversary on November 18, 2026. Rob also reported that all the Greater Wisconsin instructors attended the Midwest Train-the-Trainer Conference in Las Vegas, while the admin held their own meeting at the Central Training Center

#### **Old Business**

• **Timecard Violation Policy:** The timecard policy disciplinary progression was updated. The Policies and Procedures have been updated, and the apprentices have been informed.

#### **New Business**

Rob Giese, CTI Training Director, discussed the separation of the NCSRCC Training
Fund from the WTCS affiliation through our Standards. Discussion included that the
Training Fund is barred from prohibiting non-member participation due to WTCS's
public funding aspect; also, WTCS considers the UBC curriculum subject to their
review as part of the agreement.

The NCSRCC Training Fund has a beneficial relationship with NWTC; however, the Training Fund and its members could be better served by transitioning to "Proprietary Curriculum approval" with BAS.

The JAC reviewed the pros and cons of separating from Tech College. Scott Watson made a motion, and Maurice Mueller seconded the motion, to approve separating from Tech College beginning with the fall 2026 semester.
